Sub: Grant of composite recognition to the school from class I-II (without aid) w.e.f. 1983-84 Session subject to the fulfilment of the following terms and conditions as a Day School (in 1st Shift).

Sir,

With reference to your application on the subject cited above, recognition to your school is granted from class I-II (without aid) w.e.f. 1983-84 session subject to the fulfilment of the following terms and conditions:

1. That the school shall abide by the provisions of Delhi School Education Act & Rules framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste or creed.
3. That the school shall appoint full time qualified and eligible staff for all classes of the school as per the present norms of the Department.
4. That the management of the school shall not encroach lands of the school without the prior permission of D.E. and of no development fee shall be charged from the students.
5. That the school shall equip the science labs as per the norms of the Department and suitable facilities for practical work shall be provided to the students.
6. That a proper library shall be established and for reading room shall also be made available for as well as teachers. Books as per the ratio of 10 per student may be added.
7. That adequate sports material shall be purchased and made available to the students immediately.
8. That the school shall strictly abide by the provision of Sec.10(1) of the Delhi School Education Act and
9. That the enrolment in section shall not exceed the of students calculated @ 12 Sq.ft. per student for available floor area of the class room and the school provide adequate and sufficient accommodation as per norms of the Directorate of Education, Delhi in each number of sections should not exceed the number of existing class rooms of proper size in the school.
10. That the school shall not run any pre-primary and recognised classes or any other activities within the premises and all the recognised classes shall be held at the place at the above address only, if any. Nursery classes removed from the pre-mises of the school, Gyan Dharti School

11. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
12. That the scheme of management shall be got approved from the Department immediately.
13. That the service contract between the management and the employees shall be executed immediately.
14. That all the facilities prescribed under Rules 50 & 51 of the DSER, 1973 shall be made available to students and the provision of Rules 6, 7, 8 and 9 strictly be observed.
15. That the arrangements for good drinking water shall be made available to all the students as well as to the teachers the sanitary facilities shall also be provided to the students adequately. Health certificates may be obtained from the local body within a month.
16. That the management of the school shall create a reserve fund of Rs. 15,000 (Rs. Fifteen thousands only) in a joint account in the name of Director of Education and the Manager of the School in any scheduled bank within a month.
17. That class XI shall not be added to the school without the prior permission of the Director of Education.
18. That in the event of violation of any instructions/orders/conditions/rules and regulations of the Department shall lead to the withdrawal of recognition of the school.
19. That the school will apply for affiliation with C.B.S. through F.O. concerned immediately.
20. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to Education Officer every six months.
22. That only class IX may be introduced during the session 1984-85.

9. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at the place at the above address only. Nursery classes be removed from the premises of the school immediately, if any.
10. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
11. That the service contract between the management and the employees shall be executed immediately.
